## The Port of Seattle and Suquamish Indian Tribe sign Memorandum of Agreement



The Port and the Suguamish Indian Tribe signed a Memorandum of Agreement (MOA) expanding their government-to-government relationship and increasing collaboration on areas of mutual interest. This includes increased communications, constructive dialogue, and problem-solving to advance issues of regional importance such as economic development, treaty-reserved fishery resources, intergovernmental advocacy, cultural and archaeological resource preservation, education and job training, and fish and wildlife habitat restoration and stewardship.

### New allies join the Port Pledge to Stop Human Trafficking

On January 9, the Port of Seattle held its third annual Port Allies Against Human Trafficking (PAAHT) pledge event and was joined by two new signatories — Norwegian Cruise Line and Coastal Alaska Premier Seafoods. A total of 22 signatories have taken the pledge since its 2023 inception, which began as a Seattle-Tacoma International Airport (SEA)—specific awareness and training effort and expanded to the Port's cruise partners last year. The event marks the Port's continued commitment to preventing human trafficking through awareness, education, and tools created in partnership with regional anti-human trafficking leaders.
